## Administrative Fee Rebate

**More Good News!!!** At the May 2017 Board of Directors meeting, a unanimous decision was made to rebate a percentage of the administrative fees paid in the 2017 FY. The rebate will be issued at the end June, and can be applied to any fees due in the 2018 FY. All RMHN providers in good standing that paid Administrative fees throughout the year will be eligible for the rebate.

## CMS Announces MIPS Reporting Update

CMS has started the process of identifying the providers who will be subject to reporting under the new Quality Payment Program (QPP) Merit Incentive Payment System (MIPS) which went into effect 1/1/2017. CMS has a very functional website for QPP – [www.qpp.cms.gov](http://www.qpp.cms.gov). Get out your NPI number and visit this website to see if you are going to be subject to MIPS reporting.

If you are subject to MIPS reporting, it is not too early to start thinking about participating in the Medicare Shared Savings Plan (MSSP). Participating in the MSSP gives you advantages in 2 of the 3 QPP categories for 2018. Contact Carol Beam, CEO, if you would like to learn more about the MSSP.
